LOUIS, Apr 24, 2002 (BUSINESS WIRE) -- Centene Corporation (Nasdaq:CNTE) today announced that it intends to file a registration statement for a proposed offering of approximately 4,700,000 shares of its common stock (excluding shares subject to any underwriters' over-allotment).
