# Centene Corporation Announces Formation Of Social Health Bridge To Address Social Determinants Of Health

ST. LOUIS, Feb. 22, 2019 /PRNewswire/ -- Centene Corporation (NYSE: CNC) announced today that it has formed Social Health Bridge™ Trust to help community based organizations and healthcare entities work more effectively to address the social determinants of health – the non-medical barriers to health such as food insecurity, housing instability/homelessness, unemployment, and lack of access to transportation.

"When community and healthcare organizations begin to work together, they often face barriers to collaboration in the form of different terminology, dissimilar funding structures, administrative complexity, lack of payment arrangements, and capacity limitations," said Michael F. Neidorff, Chairman and CEO for Centene. "By bridging this gap, Social Health Bridge simplifies and accelerates the local partnerships needed to meaningfully and sustainably tackle the social determinants of health."

Social Health Bridge will work across the healthcare system with entities such as physicians, hospital systems, Accountable Care Organizations, payers, and health departments, to bring data-driven and evidence-based approaches to this work while developing value-based revenue streams for Community Benefit Organizations (CBOs) (e.g., food pantries, low income housing communities). These new revenue streams will enable CBOs to increase their capacity and expand their services. Social Health Bridge will help all partners align their efforts to achieve the health outcomes most critical to the individuals and communities they serve.

Leveraging Centene's scale and 35 years of experience collaborating across sectors to address social barriers to health, Social Health Bridge creates a platform that will enable the healthcare system and CBOs to achieve the promise of improved health by addressing social determinants while strengthening all parties. Social Health Bridge will enable bold partnerships and amplify impact for healthcare entities and community based organizations across the United States – ultimately creating local solutions to some of the nation's greatest social challenges.
